Sub.: **Intimation of embezzlement of funds by Director of Step-down Subsidiary**

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), we would like to inform you that, we have been informed by the Financial Controller of M/s Roto Pumps Africa Pty Ltd, Step-down subsidiary in South Africa, w.r.t. embezzlement of funds of the Subsidiary by its Director, Mr. Ravin Munsook Sewnarain by manipulation in accounts. He has resigned on April 30, 2025 and his settlement is pending.

The requisite details in terms of Regulation 30 of Listing Regulations read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, are enclosed as per Annexure-A.

Investigation in the matter is underway, we would update the same in due course based on the findings of the investigation.
